We Know the Void...

Last year, an estimated 600 adults aged 18-21 exited from Lee County special education programs. Several hundred more exited from Hendry, Glades, Collier, and Charlotte counties' programs. Where did they go? Day activities service providers have limited spots available for new entrants. Job carving, training, and location services are extremely limited. Social programs available through churches, community organizations, and nonprofits are limited. Respite services are sparse for parents caregiving into their 70s, 80s, and beyond.

Robert and Ben Miller were born with a rare disease and severe disabilities. They showed us a void in the world of activities for adults with such challenges. We want to fill the void with good ol' camping fun

in a safe, nurturing environment. From sing-alongs, arts & crafts, fishing, horses, and campfires to talent shows and much more, we bring campers to nature while creating an extraordinary community experience.

We are ONE family.

The Bottom Line ...

- Riverside Retreat owners communicated that Trailways Camp will have a place for our sessions as far into the future as we wish.
- Trailways Camps, Inc. received 501(c)3 approval and a designate EIN Number – 88-2818905.
- The Board of Directors grew from four to nine members.
- The Advisory Committee was activated
- Several hundred adults participated in Trailways Camps sessions and events.
- Several hundred families and caregivers received support, respite, and peace in their hearts as they witnessed the joy.
- Several hundred volunteers received as much as they gave.
- Diagnostic labels didn't define who could participate.
- Age of adults was not used to define who can and who cannot.
- Adults with special needs grieving for the passing of loved ones had a place to receive comfort, support, and spiritual encouragement.
- Giving toward costs continued as voluntary gifts.
- 100% of campers, caregivers, staff and volunteers expressed a desire to "come back."
- Expenses \$204,891, Cumulative Fund Balance \$36,328
